The State of Florida requires all licensed driving schools to disclose that they cannot make any guarantee that a student will secure a driver's license as a result of the lessons being provided.

- ❖ Payment is made to the instructor prior to the start of each lesson.
- ❖ Except for "emergencies" (as defined by the school only), 24 hour lesson cancellation is required. Short notice cancellations negatively impact other customers in need, and increase business operating costs. **Please take scheduling your lessons seriously.**
- ❖ **All driving students must have a valid permit or license in their possession to drive.**
- ❖ **A \$ 25 fee applies to any lesson a student is unable to complete once an instructor arrives.**
 - ✓ Lesson rates: \$68 for 1.5 hrs - \$90 for 2 hrs. within 20 miles of our main office in Brooksville, FL.
 - ✓ Lessons outside of 20 miles are \$100 for a minimum 2 hr lesson.
 - ✓ Cash, Check, or Credit/Debit cards are accepted. **An additional charge applies Credit or Debit use.**
 - ✓ Lessons include pick-up and drop-off **at prearranged locations** (Home, School, Business, etc...).
 - ✓ A \$35 service charge will be applied to all returned checks. The return check fee doubles if payment arrangements are not made within a week of notification.
- A SCTS vehicle may be used for the DMV road test **ONLY** if the instructor feels the student is ready to test. Cost is the same as a lesson.
- Upon request, a certificate for insurance discount purposes is available after the final lesson.
- Hard soled footwear is required for driving. No Flip-Flops, Loose Sandals or High Heels.
- Students and/or parents/guardians are responsible to disclose any medical conditions or medications being taken that may affect their ability to operate a vehicle safely.
